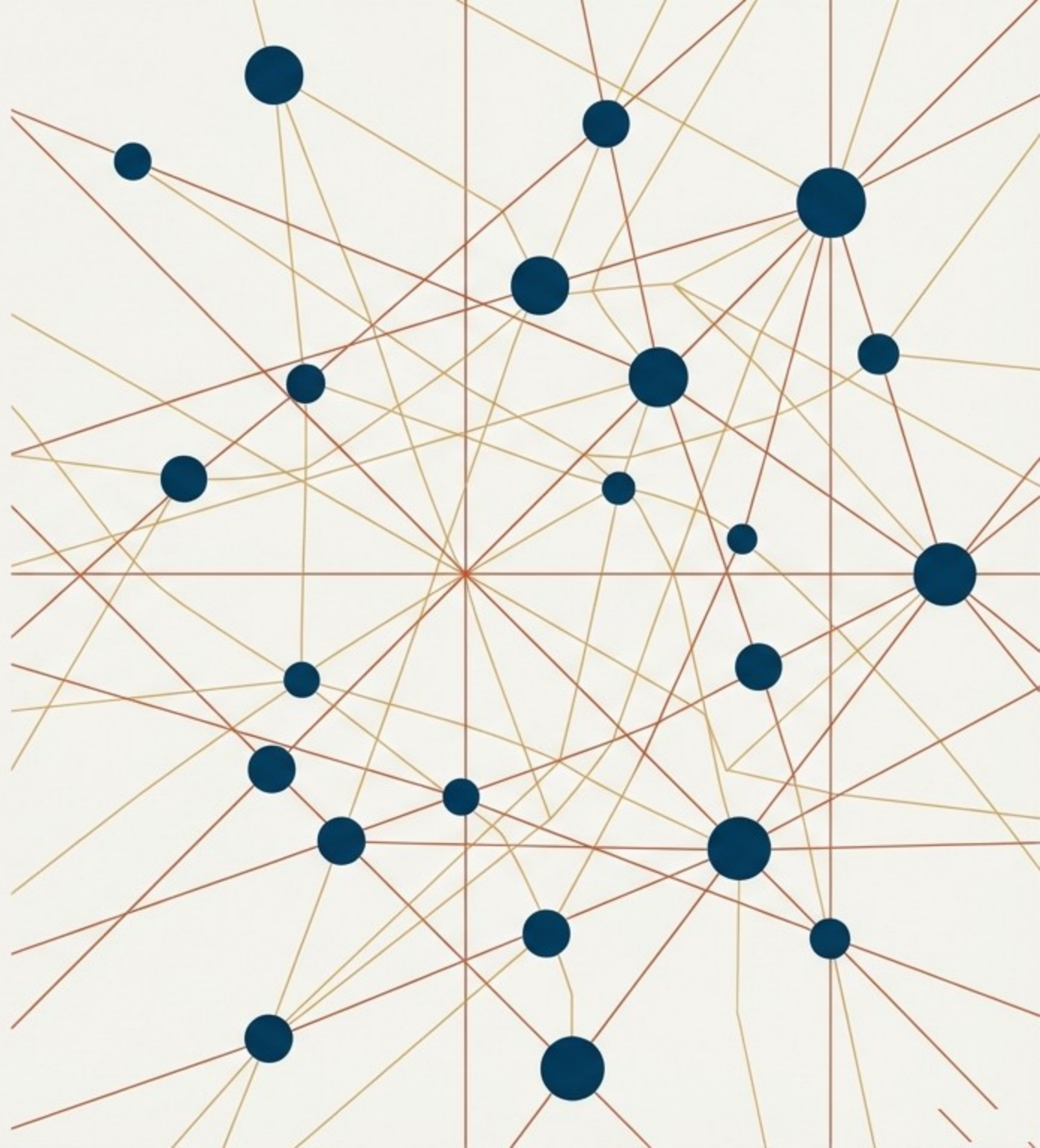

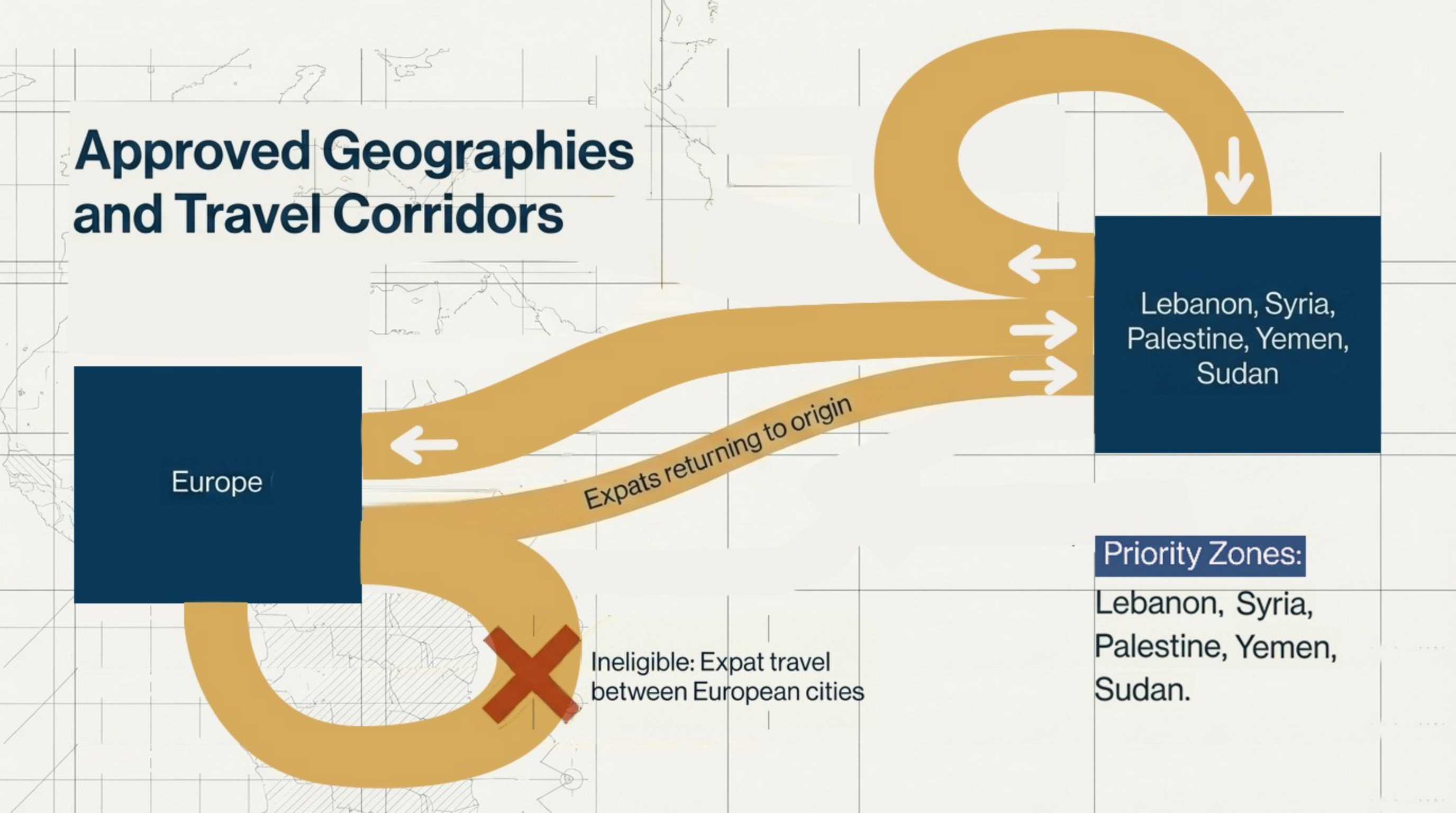

The Micro-Grant Structure: Maximizing Impact

A rapid-deployment intervention designed **specifically** to clear **immediate logistical barriers** for cultural operators.



In-Kind Support: Visible, and Counted Apart

The grant is not the whole package.

RCF can also provide, alongside the grant, **possible accommodations and local connections.**

per person

Transport, visa and per diem —
paid, reported, audited.

A single figure, on a single line
of the financial report.

Accommodation

Provided by the host partner, where applicable.



Local Connections

RCF recommends beneficiaries and makes the
introduction to partners on the ground.

When it applies, it is part of what the beneficiary receives — **only one of them is money.**

Application Protocol: Frictionless but Rigorous

Submissions in PDF format to: administration@cimettafund.org

01. Updated CV

Highlighting active professional status.

02. Short Portfolio

Documentation or active links to previous work.

03. Letter of Intent

Detailing the project and urgent mobility need.

04. Proof of Partnership

Invitation letter or agreement with a host structure.

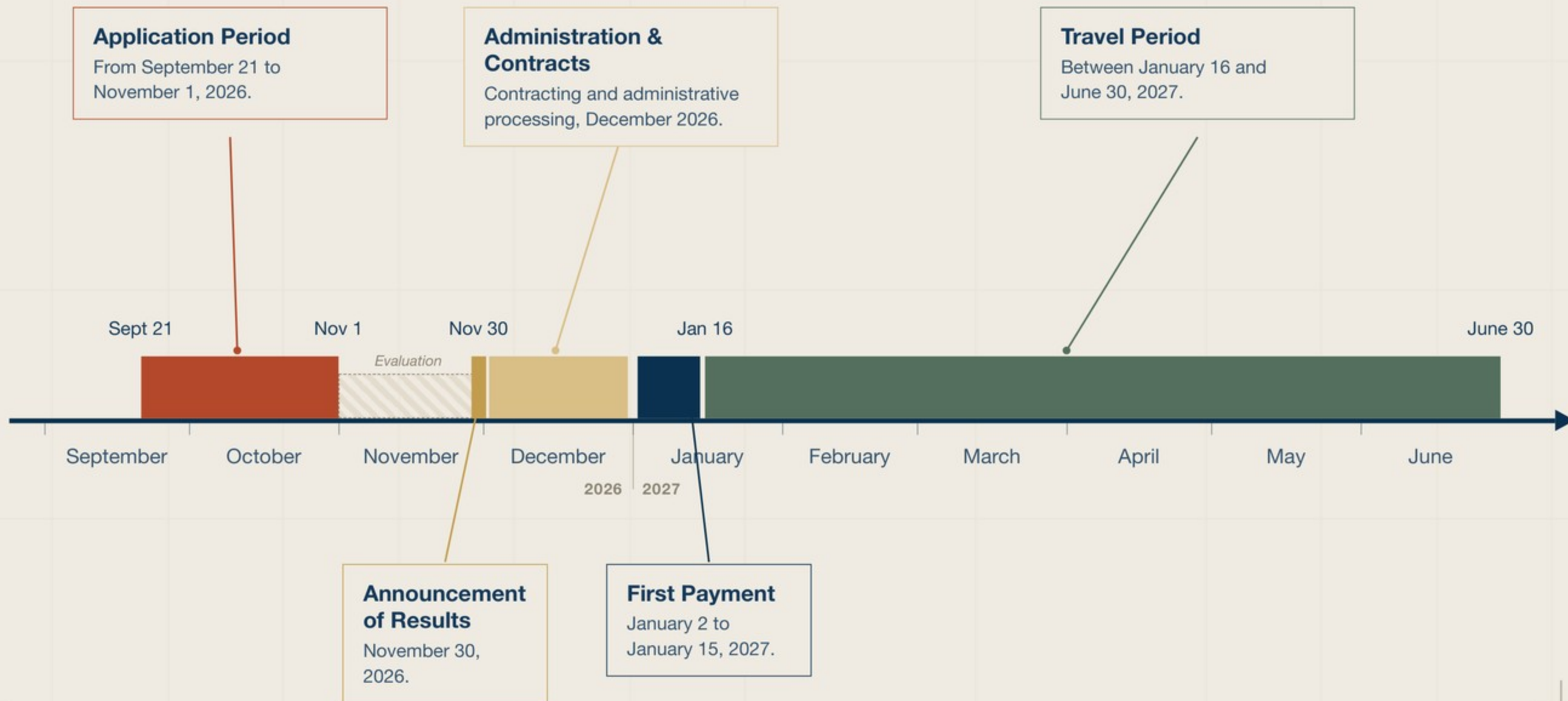
The Evaluation Engine

All applications processed by a committee of **independent experts** to ensure total neutrality.



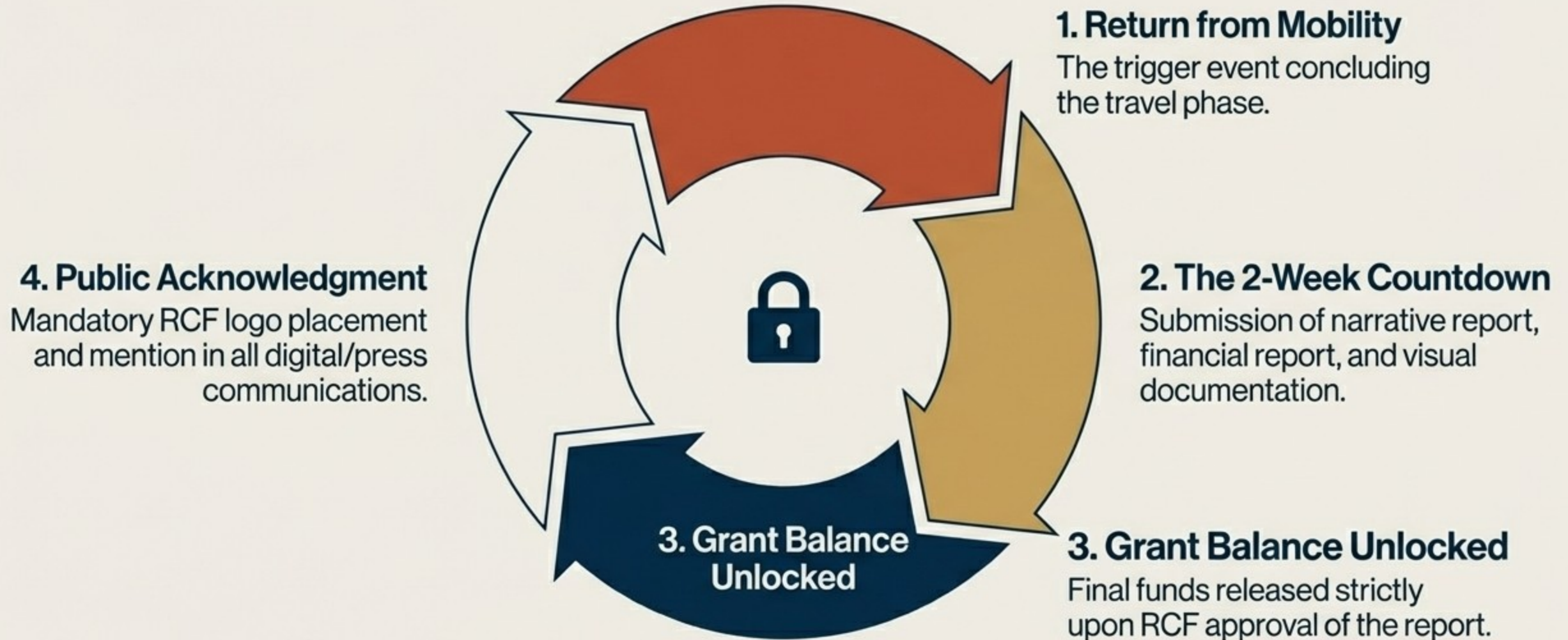
The Rapid Deployment Program 2027

Executing emergency mobility across these critical moments.



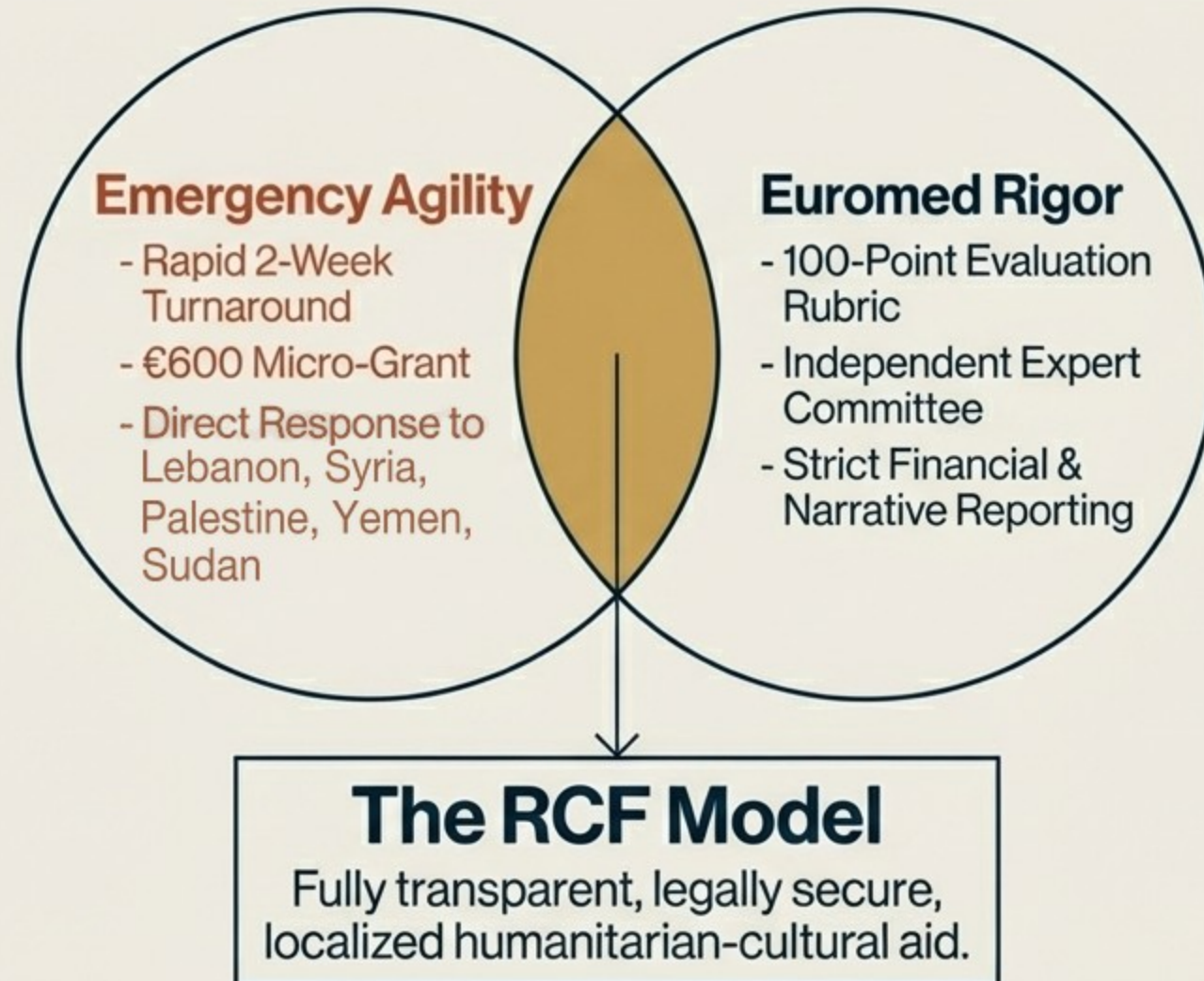
Beneficiary Accountability & Compliance Loop
